

## Attica!!!

In the summer of 1971, prisoners at Attica Correctional Facility – inspired by the burgeoning prisoners’ rights movement – pressed authorities for better conditions. Tensions rose until, on September 9, hundreds of prisoners took over the facility and took prison staff hostage, issuing a list of demands (reprinted in one of the pamphlets below). On September 13, after negotiations on the demands had stalled, state police dispatched by Governor Rockefeller forcefully suppressed the revolt, ending in the deaths of 33 prisoners and 10 prison employees – the most deadly confrontation between Americans since the Civil War. Activists outside the prison quickly mobilized to provide legal aid to those who had participated in the uprising. These groups demanded that the charges against the indicted inmates be dropped, and that those involved in the killing of prisoners be charged; they also continued to call for prison reform, citing the list of demands that the Attica prisoners had issued. For several years, as the courts slowly decided the fate of dozens of participants in the revolt, these

groups raised funds to hire lawyers, to broadcast the prisoners’ views of what had actually taken place, and to continue pushing for changes to the treatment and conditions of incarcerated people. Some groups also worked to resettle those who had been released back into society. All of these efforts are represented in the pamphlets, leaflets, and serials included in this list. Most of the items in this group were collected at the time of issue by Maurice Rovenor, a Buffalo, NY schoolteacher with an interest in radical movements. In many cases he has dated leaflets in pencil or indicated the organization from which he obtained them.

Aside from such minor markings, items are in very good condition unless otherwise described. All listings are subject to prior sale. Items may be returned for any reason within 30 days of receipt. 

First issue of a newsletter announcing activism in the Erie County area related to the defense of the Attica Brothers.



Lists the demands that prisoners from Attica had submitted to authorities in June 1971, before the uprising broke out. "It is through the demands that we get a glimpse of the conditions that were the seedbed for rebellion."





Issued after a series of "Attica - one year later" news specials had emphasized positive changes in the prison. Contains the original demands made by prisoners, each one followed by a much more dour assessment of progress in the subsequent 15 months.






same class that delivers mass death to Indo-China, that attempts to halt liberation movements in South America..." Includes anonymous letters from inmates, written soon after the prison uprising had been suppressed.





Eight 8.5x11 inch leaflets, three of them simply variants on different color paper. Titles include “Support the Attica prisoners! Demonstrate against Agnew,” “Save food for the Attica prisoners,” “What’s behind the Attica indictments,” “Attica prisoners receive food,” and “Attica / Wounded Knee, the same struggle,” announcing an event featuring Brother Rahaam, attorney Don Jelinek, and Native Americans who were at Wounded Knee. mother and an Italian-American father, had been a leader of the Attica prison rebellion. At this time he was being held in Greenhaven Prison.







Announcement of a memorial rally on the anniversary of the suppression of the uprising; speakers included attorney William Kunstler and Attica Brother Joe Little.



Announces a rally in support of prisoners still being tried for their role in the Attica prison uprising.





"The defense effort that freed Angela cost one million dollars. The 60 Attica Brothers will need many times that amount..."










Poem about the Attica prison uprising.


